CLT Program Overview

A standardized certification course, recognized throughout Canada and United States for Canadian livestock and poultry transporters

- Training modules for all major species transported in Canada
- Key knowledge areas include:
 - animal welfare, health, behaviour, laws and regulations, vehicle and handling techniques, emergency response
- Recertification every three (3) years

The many benefits of training and certification include:

- Improved knowledge
- Increased professionalism
- Improved safety
- Reduced livestock stress and injury during transport
- Decreased economic loss
- Increased public trust



A brief history...



- Originally developed by Alberta Farm Animal Care in 2007
 - All segments of the Canadian livestock and poultry sectors have contributed to the program's development
 - The program is an industry led initiative with a purpose of addressing the need for increased accountability and improved handling practices in livestock transport
- In 2013 updated and rebranded version of CLT was launched

 transitioned to the Canadian Animal Health Coalition
 (CAHC)
- In 2020, CLT program moved to Animal Health Canada and moved to primarily online delivery

AHC January 2020 Strategic Review

COMPLETED

- Short Term Actions
 - Update program based on new Transportation Regulations
 - Transition CLT to online only delivery
- Medium Term Actions
 - Establish an Advisory Committee
 - Develop sustainable financial model
 - Transition to Animal Health Canada
 - Hire a CLT coordinator
 - Update the online platform, including any needed updates to the materials – move to Momentum



AHC January 2020 Strategic Review

MOVING FORWARD

- Medium Term
 - Biosecurity modules created in 2018 and never used
 - CLT team is planning an internal review of these leveraging internal resources
 - Work with CLT Advisory Committee to ensure content works with existing policies
- Long Term
 - New learning experience for course participants to be developed
 - Obtain equivalency with US transportation training programs (TQA/BQA)

February 2022 Strategic Session

- Pre-survey of CLT stakeholders
 - 27% response rate
 - Industry goals: improve animal welfare, increase compliance with new regulations, certifications to support customer requests
 - Industry challenges: trucker shortage, high turnover, public perception, animal rights activities, reaching private/non-commercial transporters
 - Program challenges: competing, more cost-effective US-based programs, needs to be more species specific,

February 2022 Strategic Session

- Session Participant Feedback:
 - Opportunities: revisit core objectives of CLT program, searchable database of certified transporters, increase biosecurity content, build on other training and certification processes for truckers
 - Challenges: cost, low market penetration in the hog industry, training needs to be more engaging, lack of program awareness, reassess training cycle (currently 3 years)
