

Standards for Slaughter without Stunning

The National Farmed Animal Health and Welfare Council is pleased to make this document available to the public on behalf of the Council of Chief Veterinary Officers (CCVO) of Canada.

It was developed by a federal-provincial-territorial working group under the guidance of the CCVO, to serve as a guide for the implementation of existing regulations. Its use is recommended to ensure clarity and to promote consistency in implementing humane slaughter regulatory requirements in each jurisdiction in Canada. The humane treatment of animals up to the time of death is a responsibility of all persons who may be involved.
