Session 3 – COVID 19 – Unintended Consequences and Lessons Learned



Dr. Harpreet Kochhar

Dr. Harpreet S. Kochhar was appointed Associate Deputy Minister of Health Canada on April 1, 2020. Since joining Health Canada, Dr. Kochhar has become an integral player in Canada's COVID-19.

Before joining the Department, Dr. Kochhar served as Assistant Deputy Minister of the Operations Sector for Immigration, Refugee and Citizenship Canada (IRCC) where he led the delivery of the Immigration, Citizenship and Passport programs across Canada and at missions and offices abroad. He also was responsible for the implementation of key strategic projects for IRCC, including the Passport Modernization Initiative, Predictive Analytics, and the transformation of IRCC's operational delivery model.

Prior to joining IRCC, Dr. Kochhar was Associate Vice-President of Operations at the Canadian Food Inspection Agency (CFIA) from 2015 to 2017, and was Canada's Chief Veterinary Officer and Canada's Delegate to the World Organization for Animal Health. He was responsible for delivering food inspection services across the country as well as managing more than 4,000 employees. During his tenure at the CFIA, Dr. Kochhar managed several high profile cases to ensure the safety of Canada's food supply, including the official response to Canada's largest beef recall (XL foods).

Dr. Kochhar started his career by practising veterinary medicine in South Western Ontario. He has a Master's Degree in Veterinary Science and a Ph.D. in Animal Biotechnology from the University of Guelph where he also was Assistant Professor at the Ontario Veterinary College.

On a personal note, Dr. Kochhar is an active fundraiser for the Juvenile Diabetes Research Foundation and contributes to charities such as the Heart and Stroke Foundation, the Mental Health Institute, and the Liver Foundation. In 2012, Dr. Kochhar was honoured with Elizabeth II's Queen's Diamond Jubilee Medal for his professional and volunteer contributions and in 2017 he was awarded the Canada 150 Medal for community services.

In his spare time, he enjoys cooking as well as playing golf, volleyball, and skiing.



Jarrod Gillig serves as Business Operations and Supply Chain president for Cargill's North American protein business. In his role, he oversees 40 protein production facilities across Canada and the United States. Gillig has more than 22 years of experience with Cargill, during which he has held numerous positions across beef processing, including plant management.
