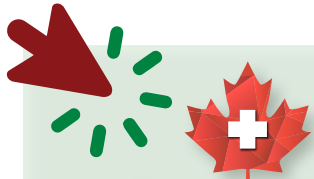
The Council was incorporated in 2010.

Animal Health Canada

Purpose: Animal Health Canada (AHC) provides a formal structure for the industry-government collaboration required to successfully implement the animal health components of the *Plant and Animal Health Strategy for Canada* (PAHS).

Structure: AHC encompasses a pan-Canadian, public-private collaboration built on the guiding principles of accountability and decision-making open to the participation of both levels of government and all animal industry sectors.

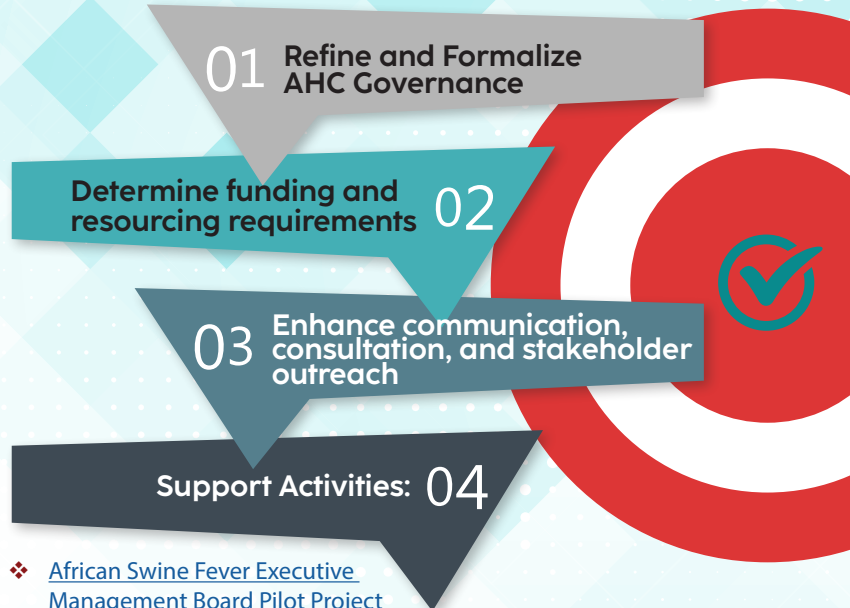
Mandate: AHC undertakes actions and delivers programs that achieve high standards of animal health protection and economic risk mitigation, consistent with the objectives and guiding principles of the PAHS.

African Swine Fever Executive Management Board (EMB)

The ASF Executive Management Board (EMB) held an all-day virtual meeting on January 26, 2021, to self-evaluate and streamline the path forward for 2021.



The top priorities for the ASF EMB in the coming year are:

- ◆ Hog Supply
- ◆ Wild Pig Management
- ◆ Recovery and Support Program Funding
- ◆ Readiness
- ◆ Biosecurity
- ◆ Communication

Work is ongoing as the EMB continues to evolve to increase knowledge transfer and information sharing with federal, provincial and territorial governments and industry.

In addition to the work already underway, shared funding from Agriculture and Agri-Food Canada (AAFC), Canadian Food Inspection Agency (CFIA), Canadian Meat Council (CMC) and Canadian Pork Council (CPC) has been secured to support EMB priorities and initiate work on developing a national integrated ASF response plan. To support these activities, we are pleased to announce that Dr. Christa Arsenault will be stepping into the role of ASF Coordinator effective April 1, 2021. We would like to extend our sincere appreciation to Manitoba Agriculture and Dr. Glen Duizer for providing support and expertise to the ASF activities as the interim ASF Coordinator since February 2021.

DIVISIONS and PROJECTS

National Farmed Animal Care Council



It's been a busy period of public comment periods for NFACC. The pig Code amendment public comment period started it all in September 2020, followed by the draft farmed salmonids Code, the mink Code amendment, and finally the draft goat Code public comment period, which ended in February 2021. Each public comment period runs for 60 days. Multiple committees are now considering the feedback received toward finalizing Codes and Code amendments.

Work also continues on the dairy cattle Code of Practice and the transportation Code of Practice. Public comment periods for those Codes are projected to begin in the Fall of 2021 and 2022 respectively.

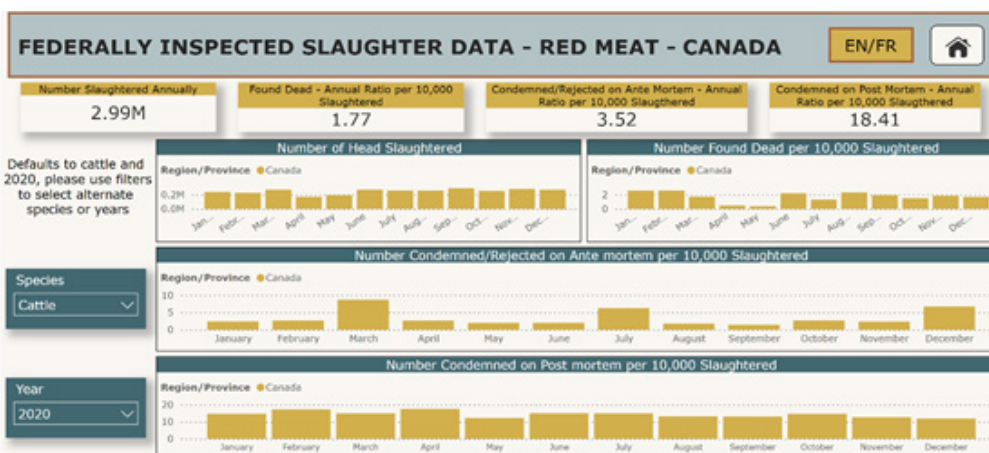

FAST FACTS!

The Council has representatives from human and animal health in order to ensure a “**One Health**” approach.

The Council has committees working on topics such as *Emerging Issues, Antimicrobial Use and Resistance, Animal Health, Animal Welfare, and One Welfare.*

The ***Federally Inspected Slaughter Dashboard***: a dashboard to show data recorded by Canadian Food Inspection Agency inspectors in Federally registered establishments, by species and regions. The dashboard is available on the CAHSS Member Portal under CAHSS Tools.



The ***AMU Metrics Reporting Project***: The *CAHSS AMU/AMR Network*, together with the Council AMU Working group, are overseeing a project to develop plain language and infographic descriptions of AMU reporting metrics and explore rationale for using specific metrics for reporting AMU in animals.

AHEM

Animal Health Emergency Management Project

- ❖ Bob Burden, who has been with the AHEM project since its inception in 2018, assumed the role of Project Manager alongside Mikki Shatosky who will continue in her role as Project Operations Manager.
- ❖ Industry protocols focusing on Non-Essential Movement and Animals in Transit are currently being finalized. Various protocol support tools (Risk Assessment Framework and a Request for Decision) have been developed and included to assist industry leaders as they work through the guidelines and recommended steps.
- ❖ We are currently in the process of organizing a scenario-based session to test specific components of the draft national Framework documents. These documents complement AHEM's provincial association Plans and producer Handbooks.
- ❖ Work with partners in SK, BC and NB on customized animal health emergency management [producer Handbooks](#) for equine, pigs, small holders, dairy and beef cattle is ongoing and progressing well.
- ❖ We continue to promote and coordinate online awareness presentations and webinars. Participant response has been very positive with feedback noting the beneficial engagement and knowledge transfer resulting from these sessions.
- ❖ We are working with Incident Command / Management System instructors and industry contacts from across Canada to develop agriculture based educational material and resources to facilitate delivery of emergency management training. Training participants will benefit from ICS-100 training and certification.
- ❖ We continue to offer [online training opportunities](#) for veterinarians, technicians and industry stakeholders. Current programs include two Foot-and-mouth Disease (FMD) courses with intakes in April and in the fall as well as an African Swine Fever (ASF) course in the fall. We are grateful for the partnership opportunities with CVMA, CFIA, EuFMD and Texas A&M, and proud to share that in 2020, AHEM provided training to 224 private practitioners.
- ❖ The AHEM team continues to play an active role in supporting the ASF Executive Management Board with financial resources, technical expertise, coordination, and alignment of outputs with other project activities and regional initiatives. AHEM resources and contributions are positive additions that have been recognized by a wide variety of ASF working group participants.
- ❖ AHEM's FMD Vaccine Strategy activity is officially underway. Working closely with industry, we've developed a draft business case for a Canadian FMD Vaccine Bank. This business case is being reviewed and will be finalized and submitted to the working group in late March.

Canadian Livestock Transportation (CLT)



As of December 2020, CLT released the Canadian Livestock Transport Course Audit for livestock and poultry to the on-line training platform. The courses provide regulatory and enforcement officers the opportunity to review the content that is being provided to transporters for \$50.00 CDN.

This is NOT a certification course and should only be used as an informational resource for regulators, enforcement officers, federal and provincial inspectors, and individuals who do not require certification.

Moving towards the second phase of the restructure plan, CLT plans to expand and enhance the on-line training experience. The program is developing an application for funding to the Canadian Agricultural Partnership AgriAssurance Program which if approved will help to further enhance the current training modules with interactive features. CLT will also be collaborating with our industry partners to look at opportunities to develop additional on-line content that may be needed by the different sectors of this industry.

CLT is currently working on developing guidelines for special event training requests particularly in the face of COVID-19 challenges while continuing the transition and adaptation to the on-line platform.
