#### **NFAHW Council meeting, September 28 & 29, 2017**

Ottawa

The Council met on September 28–29, 2017 at the Dairy Farmers of Canada office in Ottawa.

René Roy was welcomed to the Council as a designate of the Canadian Pork Council (CPC). Rene is a pork producer and is working on his PhD at McGill University while maintaining an active role in the pork industry in Quebec and on the CPC Board of Directors.

#### **Presentations**

##### **OIE Performance of Veterinary Services Assessment**

Dr. Jaspinder Komal, Executive Director Canadian Food Inspection Agency (CFIA) and Acting Chief Veterinary Officer, provided an update on the OIE Performance of Veterinary Services (PVS) assessment completed in early 2017. The report is being finalized. A more detailed report will be provided at Forum 2017.

##### **Plant and Animal Health Strategy (PAHS)**

Dr. Komal also provided a report on the Plant and Animal Health Strategy (PAHS). This led to a discussion on the potential role for Council in coordinating implementation of PAHS.

#### **Working Group Updates**

##### **Emerging Issues**

The Emerging Issues working group (WG) has partnered with the Livestock Market Interruption Strategy (LMIS) Steering Committee to make a project proposal for Agriculture and AgriFood Canada (AAFC) funding to investigate access to slaughter houses for both humane destruction and disposal (LMIS) or market access in an emerging issue event. If approved the project will result in the development of a questionnaire that will facilitate future projects for more in depth investigation and costing.

##### **Animal Welfare**

David Fraser reported on his review of the recommendations in “A National Farm Animal Welfare System for Canada – 2012”. The Council has asked the Animal Welfare WG to further develop the scope for a follow-up report to provide new and modified recommendations to enhance the animal welfare system in Canada.

##### **Farmed Animal Health and Welfare 2020 (FAHW2020)**

Caroline Ramsay and Dr. Jeffrey Spooner presented a mockup of a stakeholder report on activities which impact the strategic outcomes and priorities of FAHW2020 which was developed by Caroline from the input gathered in interviews conducted by Jeffrey. The report demonstrated presentation options and stimulated discussion. The report will be further developed and presented at Forum 2017.

##### **Antimicrobial Use / Antimicrobial Resistance (AMU/AMR)**

Steven Sternthal reported that there is a review of lessons learned from the development of the pan-Canadian AMR Framework which was recently finalized. The development of the pan-Canadian AMR Action Plan will be delayed pending this review.

The Ad Hoc Committee on Antimicrobial Stewardship will be holding a forum on October 3–4, 2017 which will be focused on leadership on AMR in animal agriculture. Rob McNabb will represent the Council at this meeting. The AMU/AMR WG will provide a document for distribution at the Ad Hoc Committee forum which will demonstrate Council leadership, actions and recommendations on AMR.

## Forum 2017

Council was updated on the Forum 2017 agenda and planning. Some suggestions were offered that will be included. A Forum 2017 agenda with registration information is included in this newsletter. The Forum 2017 promises to offer stakeholders a stimulating agenda with an opportunity to interact and network with other stakeholders with an interest in animal agriculture in Canada.

Participants are urged to register early as we have exceeded capacity in the past few years.

## Canadian Animal Health Surveillance System (CAHSS)

The Management Committee has been leading an investigation into the possibility of the Council providing leadership for CAHSS. The Management Committee and the CAHSS secretariat hosted a meeting on September 27, 2017 to discuss this possibility with CAHSS Directors.

The Council proposed the formation of CAHSS at Forum 2014. Development of CAHSS began in January 2015. The intent was that CAHSS operate with a collaborative approach and not be a federal government initiative. Council will consider how they can best support the next stage development of CAHSS, building on the good work and successes achieved to date.

## One Welfare

The working group reported that through its exploration of existing initiatives addressing mental health in the agriculture community, it has identified multiple resources. One of those, the Union des producteurs agricoles (UPA) Sentinel Program will be highlighted at Forum 2017. The working group will develop a statement that will continue to raise awareness of the need for additional support and services across Canada and include several recommendations.

## Action

Council adopted a motion to explore assuming the roles and responsibilities associated with coordination, administration, support and leadership to the CAHSS and PAHS (animal portion). Assumption of these roles is subject to the availability of adequate (and appropriate) funding.
