Recent disease challenges have increased the intensity of discussion on Canada's animal health system.


- Porcine Epidemic Diarrhea, Bovine Tuberculosis, H1N1
- Foot and Mouth Disease would collapse the red meat industry in Canada
- Canada has tremendous animal health capacity

A History of Crisis & Consequence







African Swine Fever is the latest example

- New and emerging reportable disease that poses a risk Challenges:
- No national hazard specific plan
- Roles and responsibilities are not clear
- Do the stakeholders have the resources to prepare for an emerging disease?
- A border closing disease impacting multiple species will cost industry and government billions.



There is agreement that a new way of doing things is required.

National Plant and Animal Health Strategy

- Assess other countries' approaches for domestic partnerships for feasibility in the Canadian context
- Develop mutual resource-sharing agreements, including those for surge capacity, between key partners
- Develop a process for enabling targeted partnerships for carrying out activities
- Incorporate industry as signatory to Foreign Animal Disease Emergency Support Plan (FADES)

Vancouver 2018: FPT Ministers agree on "the importance of putting measures in place to support the sector in dealing with animal health emergency issues"

The processing sector: is taking on a larger role as they begin to appreciate the risk to their businesses.

Sept 19, 2018: meeting of livestock, meat and dairy leaders <u>including major processors</u> to discuss how to approach a new animal health model for Canada

The livestock industry remains committed.

But it can't just be small, incremental change. We must construct a new reality, a new culture.

- A Real Industry-Government Partnership
 Policy, operational and financial
- With Collaborative Decision Making

 Not just industry consultation as input to the FPT Process
- Recognition of industry resource contribution



- An acknowledgment that there is a shared risk and that we share the responsibility of addressing these risks
- A better understanding of what resources are being employed and where additional resources might be needed.

An Opportunity for Better Governance

 It is our objective to present a proposal to FPT Ministers in July 2019 that would secure their commitment to develop and implement *Animal Health Canada* by July 2020.



What could success look like?

"Animal Health Canada"

- A new governance model to enhance Canada's capacity for animal disease prevention, preparedness, response and recovery
- A true industry, federal and provincial government partnership
- Industry -government collaborative management and decision making with resource sharing and financial commitment



Animal Health Canada Guiding Principles

- 1. Industry-government collaborative decision-making and management, with an independent and enduring mandate;
- 2. A model underpinned by industry-government resource sharing and financial commitment;
- 3. A multi-species, "Team Canada" approach that maximizes the strength of "front line" resources in disease prevention and emergency response;
- 4. A model that helps drive action across a comprehensive, evergreen Animal Health Strategy
- 5. A fresh approach, undertaken with ambition and pragmatism, striving for progress not perfection, with accountability resting on the most senior industry and government leaders.



Current Status

- A letter was sent to federal, provincial and territorial Ministers of Agriculture to seek support for the Animal Health Canada concept
- 13 Executives representing industry groups and processors have signed to date, with industry pledge of \$130,000



Next Steps

- A CEO level government and industry "Champions Steering Committee" will be established to demonstrate the importance of the initiative, ensure project timelines are met, encourage government engagement and support, and guide the efforts of the working group.
- Ongoing outreach to industry stakeholders and FPT Governments to seek engagement
- Commitment from participating stakeholders (FPT Governments, companies and associations) to identify human and/or financial resources to support the building process.



Next Steps

 Participating industry stakeholders are committed to engaging in a "building process" to develop the new model

- make recommendations for decision by FPT Ministers in summer 2019

- Review models from other countries, and other programs
- Develop the model then integrate organizational mandates and resources where possible
